



High blood pressure (hypertension): Wharfedale & Silsden

- Estimated hypertension prevalence in England is about 26% of all adults
- Risk factors include older age and social deprivation. Estimated hypertension prevalence in people aged over 60 is above 60%
- Public Health England estimated in 2017 that for every 10 people diagnosed with hypertension another 7 remain undiagnosed and untreated.
