
Bingley Rural (18,869) has the highest population of residents in the Shipley constituency followed by Bingley with 18,042.


Age



60% of the population in Shipley are aged 16 to 64 years with 18% aged 15 years and under and 22% aged 65 years and over.

The estimated population of Shipley's 65 years and over (21,220) is higher than aged 15 years and under (17,626). The proportion of residents aged 65 years and over (22.0%) is higher when compared to the overall district (15.2%)

The graph shows the age distribution for the population of Shipley split by female and male.


Shipley has a higher older population for both male and female compared to the district

6.7% (6,554) of the population in Shipley describe themselves as Asian, Asian British or Asian Welsh compared with 32.1% in the district.




Wider Determinants of Health

In 2022, there was an estimated 16.9% of children in Windhill and Wrose (583) in absolute low income families compared to 13.9% (2,469 for Shipley constituency and 28.9% for the Bradford district. All wards within Shipley constituency were lower than Bradford district.


In 2020, there was an estimated 6,218 (14.0%) of households in Shipley in fuel poverty compared to 18.5% in the district.

Windhill and Wrose was estimated to have 19.0% of households in fuel poverty, followed by Manningham with 15.5%. 5 of the 6 wards in Shipley were lower than the district.

Unemployment (working age population claiming out of work benefit)


Shipley has a lower proportion (4.0%) of the working age population claiming out of work benefits compared to the district (8.2%).

Windhill and Wrose has the highest proportion within the constituency (6.8%) followed by Shipley with 5.3%. Wharfedale had the lowest proportion at 1.6%.

Life Expectancy 2018-20




Female life expectancy is higher than the district average in all of the Shipley wards. The lowest female life expectance was in Baildon (82.5 years) and the highest in Wharfedale (87.2 years followed by Bingley Rural (84.0 years).

The male life expectancy is higher than the district average in five of the six wards in Shipley. Shipley ward has the lowest life expectancy for males (76.0 years) with Wharfedale the highest at 82.9 years.


Premature mortality - Respiratory (Under 75)

Shipley's rates for under 75 respiratory mortality average (28.9 per 100,000) is significantly better than the district average (41.4 per 100,000). In 2018-20, Shipley (56.7 per 100,000) had the highest under 75 respiratory mortality rates followed by Windhill and Wrose (48.9 per 100,000) higher than Bradford district.

Wharfedale had the lowest rate at 4.9 per 100,000.




Premature mortality - cardiovascular diseases (CVD) - Under 75



Shipley's rates for U75 CVD mortality average (71.2 per 100,000) is significantly better than the district average (100.9 per 100,000). In 2018-20, Shipley (115.7) had the highest U75 CVD mortality rates in Shipley constituency with Wharfedale the lowest rate, 42.0 per 100,000.

Premature mortality (Under 75) - Cancer



Shipley's rates for U75 cancer mortality average (119.6 per 100,000) is lower than the district average (135.5 per 100,000).

In 2018-20, Windhill and Wrose (146.7 per 100,000) and Bingley Rural (121.3 per 100,000) had the highest U75 cancer mortality rates in Shipley.


Shipley had the lowest rate, 107.5 per 100,000 followed by Baildon with 110.1 per 100,000.

Child Health


Infant Mortality 2018-2020

Shipley's infant mortality rate (3.6 per 1,000 live births) is lower than Bradford average (6.0 per 1,000 live births).

Bingley Rural has the highest rate 8.1 per 1,000 live births within Shipley followed by Windhill and Wrose at 6.2 per 1,000 live births.



Reception excess weight



The prevalence of reception aged children who are overweight (including obesity) in Shipley constituency (21.3%) is lower compared to the district average (22.5%).


Windhill and Wrose has the highest prevalence of reception aged children who are overweight (24.5%) followed by Keighley East (23.7%) higher than the district.

Wharfedale has the lowest prevalence of 18.1% within Shipley constituency.


Year 6 excess weight

Shipley's average Year 6 excess weight (31.8%) is below the district average (41.5%). Windhill and Wrose has 42.5% of Year 6 children that are overweight or obese, which is higher than the district average.

Wharfedale has the lowest prevalence of 21.4% followed by Baildon (28.8%) and Shipley (28.8%).



Under 18 conception rate (per 1,000 population)




In 2017-19 the average under 18 conception rate in Shipley was 17.1 per 1,000 population lower than the district average of 17.2 per 1,000).

The highest rate was in the Windhill and Wrose ward (26.1 per 1,000) Shipley the lowest (9.2 per 1,000).

Emergency admissions due to injury in under 15 year olds


2016 – 2021 emergency admissions due to injury in children and young people under 15 years old rate is 100.4 per 10,000 population for Shipley. This is lower than the district rate of 113.4 per 10,000.

Windhill and Wrose had the highest rate in Shipley constituency (129.5 per 10,000) with Shipley 115.7 per 10,000. 4 of the 6 wards in Shipley were lower than constituency and the district rate.

Depression and Mental Health



In 2020-21, the estimated prevalence for depression is 9.4% with 0.9% for mental health within Shipley.

Windhill and Wrose is estimated to have the highest prevalence of depression followed by Shipley. For mental health, Shipley has the highest prevalence estimates.


Disease and Poor Health

Coronary Heart Disease (CHD), Chronic Obstructive Pulmonary Disease, Dementia, Diabetes and Obesity

In 2020-21, the estimated prevalence for Coronary Heart Disease (CHD) for Shipley constituency is 3.2% with Chronic Obstructive Pulmonary Disease (COPD) 1.9%.


Bingley Rural has the highest prevalence of CHD (3.5%) and COPD (2.4%) within Shipley constituency.

For diabetes Shipley is estimated to have the highest prevalence at 7.3% for diabetes and Windhill and Wrose for obesity (7.2%).
